We believe votes against the proposal were warranted based on an evaluation of estimated cost, plan features, and grant practices. Overall, we believe votes against were warranted due to the following key factors: the equity program is estimated to be excessively dilutive, the plan cost is excessive, the three-year average burn rate is excessive, the plan permits liberal recycling of shares, and the plan allows broad discretion to accelerate vesting.
