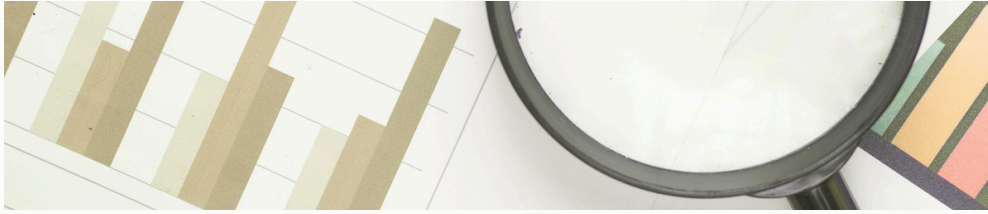

Based on that, we believe Sonos needs board members with strong Technology / Hardware / Software backgrounds to assist management. Elect director Joanna Coles has a journalism/marketing background.

Additionally, we have concerns around the company paying out its former CEO a cash severance that was not disclosed as an involuntary departure.
